**PUBLIC HEARING** : 7:45 p.m. – to take testimony on the proposed preliminary budget for fiscal year ending December 31, 2017 including capital projects and the 2017 – 2022 Capital Facilities Plan. The proposed budget includes a 2% rate increase for water, sewer and stormwater fees; increasing the monthly billing for the average customer bill by \$3 (based on average customer usage of 500 cf to 600 cf/month). A second public hearing on the proposed budget will be held on December 12, 2016.
